COVERAGE L AND COVERAGE M

1. Coverage L and Coverage M are extended to include the Agribusiness Pursuits shown in the Schedule, in connection with the *farm premises*.

AGRIBUSINESS PRODUCTS/COMPLETED OPERATIONS

The definition of *products/completed operations hazard* and any other Products/Completed Operations coverage contained in *your* policy do not apply to the Agribusiness Pursuits shown in the Schedule.

1. Agribusiness Products Hazard

We pay those sums when the *insured* is legally obligated to pay damages because of *bodily injury* or *property damage* arising out of the *named insured's products* manufactured, sold, handled or distributed on or from the *farm premises* described in this policy, in connection with the Agribusiness Pursuits shown in the Schedule. This coverage applies after physical possession of such products has been relinquished to others.

2. Agribusiness Completed Operations Hazard

We pay those sums when the *insured* is legally obligated to pay damages because of *bodily injury* or *property damage* arising out of *your work* in connection with the Agribusiness Pursuits shown in the Schedule. Agribusiness Completed Operations Hazard applies only if the *bodily injury* or *property damage* occurs after such work has been completed. *Your work* does not include incomplete or abandoned work. *Your work* will be considered completed at the earliest of the following times:

- a. When all work specified in *your* contract has been completed;
- b. When all work to be done at a job site has been completed if *your* contract includes work at more than one site; or
- c. When *your work* at a job site has been put to its intended use by someone other than another contractor or subcontractor working on the same job site.

Your work which requires further service, maintenance, correction, repair or replacement because of a defect or deficiency, but which is otherwise complete, shall be considered completed.

WHAT WE DO NOT PAY FOR

The coverage provided by this endorsement does not apply to *bodily injury* or *property damage*:

- 1. Resulting from activities in connection with an *insured's business*, other than the Agribusiness Pursuits shown in the Schedule;
- 2. Resulting from the rendering of or failure to render *professional services* of any nature;
- 3. Resulting from any contractual obligation, assumed, entered into or for which *you* or *your* agents and *employees* may be legally liable;

- 4. Damages claimed for any loss, cost or expense incurred by *you* or others for the loss of use, withdrawal, recall, inspection, repair, replacement, adjustment, removal or disposal of:
 - a. The named insured's product;
 - b. Your work; or
 - c. Impaired property;

if such product, work or property is withdrawn or recalled from the market or from use by any person or organization because of a known or suspected defect, deficiency, inadequacy or dangerous condition in it.

- 5. From operations in connection with the transportation of property, unless the *bodily injury* or *property damage* arises out of a condition in or on a vehicle created by loading or unloading; or
- 6. From the existence of tools, uninstalled equipment or abandoned or unused materials.

HOW MUCH WE PAY FOR LOSS OR CLAIM

Settlement of liability losses covered by this endorsement will be made in accordance with the following added provisions:

- 1. The limits of liability for Coverage L and Coverage M do not increase by the addition of this endorsement.
- 2. The limit of liability for Coverage L shown in the Declarations is the maximum amount **we** pay for loss in a single **occurrence** for the Agribusiness Products/Completed Operations coverage.
- 3. The Agribusiness Products/Completed Operations Aggregate shown in the Schedule is the maximum amount *we* pay for all Agribusiness Products/Completed Operations losses during a policy period.

All other terms and conditions remain unchanged.
